**Dwyka Resources Limited ('Dwyka' or the 'Company')**

**Issue of shares under the Dwyka Resources Share Plan**

The company announces that in accordance with the shareholder approval received on 30 November 2007, it has today issued 850,000 shares under the terms of the Dwyka Resources Share Plan to employees of the Company.

Application has now been made to the AIM market of the London Stock Exchange ('AIM') for 850,000 Shares to be admitted to trading on AIM ('Admission'). Admission is expected to occur at 8.00am on 17 December 2007.

Following this issue, Dwyka now has 131,344,206 Shares in issue.
